A thesis of 60000 words has to be submitted and plagiarism will be checked 80% should be their original content.




Anyone can apply no barrier regarding academic background.

# ASSESSMENT

## Task 1.1

Describe your current professional context. What is the current thinking about good practice in that context? Give examples of good practice and bad practice from other companies in the same or similar industry. Provide evidence from your company's publicly available information about your current position.

## Task 1.2

Describe your leadership journey from the beginning of your professional career to your current stage. What do you feel you have learned about yourself and about leadership during this journey? Provide evidence of your current responsibilities, lines of reporting etc.

## Task 1.3

Read this article. There is information about different leadership styles. Reflect on your current and recent practice and give examples of when you have demonstrated different styles of leadership. Provide evidence of your work from a colleague. In a separate document consider your current understanding of your leadership strengths and weaknesses and formulate a plan for overall improvement.

## Task 1.4

Undertake a 360 degree evaluation of your leadership with at least 4 of your current colleagues. When the results are available, take time to consider the results and their implications for your practice. You are free to choose who you ask to participate, but choose people who will give honest feedback.

- Passport or National ID
- Recent photograph
- All-Academic transcripts and degrees
- Work Experience letter and supporting documents
- Reference from any one employer or last academic provider
- Proposal form- 3000 to 4000 words
- IELTS overall 6.5 bands or Video Admission Interview
- Publishing history (if any, it is an optional)
- Bachelor's degree holders with a minimum of 6 years of managerial experience are eligible to apply; a Master's degree is not required.
- No age limits
